

## Privacy Policy

The **MeliSpace video game** is owned by **iAweb.us**, which is a data controller of your personal data.

We have adopted this Privacy Policy, which sets out how we process information collected by **MeliSpace**, which also provides the reasons why we should collect certain personal data about you. Therefore, you must read this Privacy Policy before playing **MeliSpace**.

We take care of your personal data and we are committed to guaranteeing its confidentiality and security.

Personal information we collect:

When you play **MeliSpace**, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies installed on your device. In addition, as you browse, we collect information about the individual web pages or products you view, what websites or search terms referred you to the web, and how you interact. We refer to this automatically collected information as "Device Information." In addition, we may collect the personal data you provide to us (including, but not limited to, first name, last name, address, payment information, etc.) during registration in order to fulfill the agreement.

### Why do we process your data?

Our highest priority is the security of customer data and as such we may process only minimal user data, only to the extent absolutely necessary to maintain the website. The information collected automatically is used only to identify potential cases of abuse and to establish statistical information on the use of the website. This statistical information is not aggregated in such a way as to identify any particular user of the system.

You can visit the website without telling us who you are or revealing any information by which someone could identify you as a specific person. However, if you wish to use some of the website's features, or wish to receive our newsletter or provide other details by completing a form, you may provide us with personal data, such as your email, first name, last name, city of residence, organization and phone number. You can choose not to provide your personal data, but you may not be able to take advantage of some of the website's features.
